Who we are

NJ-AHIMT provides scalable incident management support to jurisdictions before, during, and after emergencies and planned events. Our cadre includes qualified personnel across all ICS sections and key unit-level specialties. Formed to support local, regional, and state-level incident response, the NJ-AHIMT is designed to manage complex incidents and planned events that exceed the capabilities of local jurisdictions. The team operates under the principles of the National Incident Management System (NIMS) and the Incident Command System (ICS).

CORE CAPABILITIES:

- **Incident Command Support:** Provides command and general staff positions to manage incidents or events.
- **Multi-Agency Coordination:** Facilitates coordination among federal, state, local, and tribal agencies.
- **Planning & Logistics:** Develops Incident Action Plans (IAPs), manages resources, and supports logistical needs.
- **Operational Support:** Assists with situational awareness, resource tracking, and operational planning.
- **Technical Expertise:** Offers specialized knowledge in areas such as public safety, emergency medical services, public health, and hazardous materials.
- **Scalable Deployment:** Can be deployed in full or modular configurations based on incident complexity and needs.

FUNCTIONS:

- **Incident Management Team**
 - Assume management of the incident for the requesting jurisdiction
- **Incident Support Team**
 - Provide support to a local Incident Commander/Unified Command
- **Emergency Operations Center (EOC)/Support Team**
 - Provide support and assistance to an EOC

HOW TO REQUEST THE NJ-AHIMT:

- **In-State**
 - Follow normal EMMIT request procedures thought County OEM and SEOC.
- **EMAC**
 - Request via your state EMAC coordinator (MRP details available on request).
- **SRT**
 - Coordinate with your local FEMA Region or email the SRT Program
- **IROC**
 - Coordinate with your states ESF 4 representative.
